MEETING MINUTES

1. Chair Bob Frank called the meeting to order at 10:01 AM.
2. Quorum established with 12/14 members present.

3. Meeting minutes from April 20, 2023, considered for approval.
Motion to approve by Hardman; seconded by Podoll. Unanimous approval.
4. AT&T ESInet/NGCS Contract
 - A. As of June 22, 2023, 92 PSAPs have signed a participation agreement; 41 have active projects and many are in the project management queue to start project planning and site surveys.
 - 1) The 92 PSAPs include 64 counties, 26 municipalities, UW-Madison, & UW-Milwaukee.
 - St. Croix and Waupaca counties are live!
 - Oneida and Shawano counties are scheduled to go live in July, pending successful operational readiness testing.
 - B. NG9-1-1 Buildout Status map presented.
 - 1) Any feedback on the map (display, readability, data, etc.) can be sent to the interop@widma.gov mailbox.
5. NextGen9-1-1 GIS Update
 - A. Discussed the phased i3 approach for submitting data to the AT&T EGDMS.
 - 1) Currently Columbia, Jefferson, Vernon, Walworth, and Rock counties have indicated interest in using the phased i3 approach.
 - B. Provisioning boundary service layer is available on the DMA ArcGIS online portal.
 - C. Zach Hassler continues to hold monthly state NG9-1-1 GIS calls; next call is July 17th.

6. NextGen9-1-1 Grant Programs Update
 - A. Announced the upcoming grant announcements for FY24, *all contingent on the next state biennial budget.*
 - 1) PSAP grant announcement was released and the application due date is August 1st.
 - Anticipating \$6 million for FY24, with a 10% local match.
 - 2) GIS grant announcement is anticipated to be released by the end of June.
 - Anticipating \$1.5 million for FY24, with a 5% local match.
 - 3) No grant awards will be announced until after the state budget is passed.
7. CISA Technical Assistance COOP Template Update
 - A. Jessica Jimenez announced the PSAP COOP template final webinar is scheduled for June 28th at 2:00 PM.

8. Federal 9-1-1 Update
 - A. Jimenez provided an update on Federal 911 initiatives.
 - 1) FCC issued a Notice of Proposed Rulemaking, regarding the matter of facilitating implementation of NG9-1-1 services.
 - 2) FCC Annual 911 Fee Report due June 30th.
 - Includes reporting on the usage of multi-purpose fees, such as the \$0.75 police and fire protection fee.
 - 3) National 9-1-1 profile database
 - Wisconsin submitted report on June 1st.
 - 4) Federal NG9-1-1 grant bill
 - Grant Grywalsky will be monitoring and providing updates as the bill moves forward in Congress.
 9. 9-8-8 Update
 - A. Bob Frank introduced Margaret Marcou, the 988/911 Outreach Coordinator supporting the WI-Department of Health Services
 - 1) Marcou provided an overview on the 9-8-8 Mental Health Crisis Lifeline and briefly discussed their current efforts.

 - Subcommittee requested monthly statistics to be provided on a regular basis.

 - A. There was discussion on potential draft bills relating to grants for incumbent local exchange carriers for costs associated with NG9-1-1.
