1. Meeting called to order at 1:01 PM.

2. Review and approval of September 06, 2019 meeting minutes.

Motion to approve the meeting minutes by Lange. Seconded by Lindert. Unanimous approval

H. Discussion and action to give Erik Engel an extension on the timeline to complete his PTB.

Motion to give Erik Engel a 1-year extension on the timeline to complete his PTB (giving him a total of 5.5 years) but requiring a final evaluator to observe and sign-off by Guse. Seconded by Lange. Unanimous approval

- 7. The WI FOG update will be addressed in early 2020.
- 8. WI CASM Policy
  - A. Boss informed the group that OEC staff will draft this and present it to the COMU WG for input.
- 9. Other Business
  - A. Hughes informed the group that Doug Lofreddo is deployed for approximately the next 10-11 months and also provided other WEM updates regarding SIMCOM, FirstNet, and new devices.
