4. Public Comment:

5. Old Business:

- A. Questions received concerning WISCOM upgrade – Keith Kesler.  
Additional input received from local departments expressing concern or lack of knowledge about WISCOM move to 800. Encourage all to wait for information.
- B. West Central Region open position on WISCOM subcommittee – Keith Kesler.  
Kesler informed the committee two applications were received for the open position (West Central Region) on the WISCOM subcommittee. Discussion.

- C. Outreach – Torre Peterson-Waldvogel

Consider use of WEM personal – regional directors and county/local directors to share information with local agencies.
  - D. Webpage – Keith Kesler  
Margaret Zieke has been “word smithing” the potential webpage as presented at the last meeting. She was unable to attend due to another commitment. Kesler will forward when completed.
6. New Business:
- A. OEC Update – OEC Staff.
    - 1) RFP – Erik Viel reported that the RFP responses from vendors were due on April 5<sup>th</sup>. Those responses are currently being reviewed. When the award is issued he will email all contacts. Please assist by sharing the news broadly. State of Wisconsin procurement policies do not allow for details of the procurement process to be released.
    - 2) NQS (National Qualification System) – Viel reported that OEC is working with WEM to identify how to conform to the NQS. An advisory work group including OEC is working on how to implement.
    - 3) WISCOM Data
      - a) Presented overview of data related to PTT (push-to-talk) and talkgroup usage.
      - b) Reported new user in Kenosha County: Village of Salem Lakes Fire and Rescue.
  - B. SCIP (State Communications Interoperability Plan) Update:  
Viel reported that the SCIP draft will be presented at the IC meeting tomorrow, July 28<sup>th</sup>. Please attend the IC meeting if you want more information.
  - C. Air Medical – Chad Crowley echoed the need for outreach as his organization was not aware of the planned changes to WISCOM. He mentioned the ability to talk with a handheld from the Milwaukee to the UP and the benefit WISCOM provides at present.
