MADISON, Wis. – The Office of Emergency Communications (OEC) is pleased to announce the award of 39 grant projects totaling \$5,721,074.98 in state funding to local public safety answering points (PSAPs) across Wisconsin.

Funding will be used for various projects related to PSAP equipment upgrades and advanced training necessary for Next Generation 9-1-1 (NG9-1-1) implementation. A summary of the grant awards is detailed below.
